

# **RULES AND REGULATIONS OF THE MARCH MANIA BIG PRIZE GIVEAWAY**

## **Article 1**

These Rules regulate the procedure and conditions of participation in the March Mania Big Prize Giveaway (hereinafter: Giveaway) organized by GameBoost (Global Gaming Services d.o.o.) hereinafter referred to as "Organizer" and "Manager of personal data processing".

The purpose of these Rules is to ensure equality for all participants or contestants and to provide equal opportunities to win gifts, all of which is stated after fulfilling the conditions stated in these Rules. The organizer is solely responsible for the content of the contest.

## **Article 2**

The giveaway is held from 03/01/2023 at 12:00 p.m. (CET) until 3/31/2023 at 12:00 p.m. (CET) on the official GameBoost website <https://gameboost.com/>.

## **Article 3**

All people of legal age have the right to participate in the giveaway, except employees of the Organizer as well as members of their immediate families (parents, spouse, children, sisters and brothers) (hereinafter: Participants or contestants).

## **Article 4**

A person from Article 3 of these Rules who wants to participate in the giveaway must, during the giveaway period, create make at least one purchase on the Organizer's website. The purchase must be made on the official GameBoost website <https://gameboost.com/> and it must be done completely.

## **Article 5**

The winners of the giveaway will be chosen out of all users who have made a purchase on the official Organizer's website. The winners of the gift will be announced on the March Mania page on the official Organizer's website <https://gameboost.com/event/march-mania>

At the end of the Big Prize Giveaway, **14** winners will be announced - one winner for the first place, three winners for the second place, and ten winners for the third place. The gifts for every place won are stated here:

- First place - **1** x Gaming PC (retail value €3,000,00) + GameBoost hoodie
- Second place - **3** x Headset/Mouse/Keyboard package + GameBoost hoodie
- Third place - **10** x of €20,00 GameBoost Vouchers

Gifts can't be exchanged for money, or transferred to another person.

The winner for each place will be announced on the official GameBoost March Mania page, and will be contacted via email ([support@gameboost.com](mailto:support@gameboost.com)) directly on the day of the announcement. Third place winners (10) will be given a personalized GameBoost gift code worth €20,00 which can only be used on the GameBoost website (<https://gameboost.com/>) and redeemed at the checkout. The gift code can be used for purchasing boosting service for these games: League of Legends, VALORANT, World of Warcraft, LoL: Wild Rift, Overwatch 2 and Teamfight Tactics.

### **Article 6**

The organizer reserves the right to disqualify registered participants at any time if:  
The Participant violates these Rules or Participant acts against the Rules of the platform.

### **Article 7**

GameBoost (Global Gaming Services d.o.o.) is the manager of the processing of personal data of participants or competitors of the giveaway. The controller collects and processes personal data, based on consent and legitimate interest, such as name, surname, location, country, e-mail, gender, IP address, date of birth, photo, as well as other data that the Participant or competitor has made available on their GameBoost Client Area profile.

Personal data of respondents may be processed for a purpose other than that specified in the Rules if this is necessary to comply with legal obligations (e.g. to submit data to courts or law enforcement authorities), if the Participant or competitor has agreed to the appropriate processing or if the processing is in another way legal according to binding regulations. If the data is processed for another purpose, before processing, the data controller will provide data subjects with information about that other purpose.

Access to the personal data of contestants or participants in the giveaway is granted to people authorized by the processing manager, such as the marketing department, legal department and consultants who help IT support for the above systems. Authorized third parties may need to access or store personal data if required or permitted by binding regulations (e.g. government bodies, courts, outside counsel and other third parties deemed to be public authorities).

The data controller will process the data collected in the giveaway for as long as it is necessary for the above-mentioned purposes, i.e. until the end of the giveaway. We store personal data submitted as part of the application for the giveaway after the announcement of the winners, in order to resolve any complaints related to the conducted giveaway.

If the processing is based on the consent of the contestant, that is, the participant has the right to withdraw consent at any time. Withdrawal of consent must be notified to the data controller at e-mail: [support@gameboost.com](mailto:support@gameboost.com). Such withdrawal will not affect the lawfulness of processing based on consent prior to its withdrawal. If judicial, administrative or extrajudicial proceedings

have been initiated, personal data may be stored until the end of such proceedings, including the possible period for filing legal remedies.

### **Article 8**

The organizer, as well as the legal entities that perform actions related to the implementation of the giveaway in the name and on behalf of the organizer, do not assume responsibility for:

- any consequences resulting from the incorrect use or abuse of the conditions of the giveaway by participants or competitors or third parties,
- unwanted consequences suffered by participants due to participation in the giveaway, (non)functioning of the giveaway event page, consequences of (non)functioning, regardless of the reasons for (non)functioning,
- (in)accuracy of data sent by participants or contestants in the giveaway.

### **Article 9**

Any handling of personal data by the organizer is in accordance with the principles defined in the Data Protection Policy, available on the official website of the Organizer. Each participant has the right to request their rights (right to access, correction, deletion, restriction of processing, right to object and portability of data) from the Organizer (Processor) in accordance with the aforementioned Policy.

### **Article 10**

The organizer reserves the right to change the rules and conditions of participation in the giveaway. The giveaway can only be terminated in the event that circumstances arise for which the organizer is not responsible, that is, which he could not prevent, eliminate or avoid.

The organizer will inform the participants and competitors about all changes via the official website of the Organizer.

### **Article 11**

The winner bears no taxes, duties or fees directly related to the prize awarded in this giveaway.

### **Article 12**

These Rules apply from the day the giveaway is published on the Organizer's website.
